1. Introduction

This document is a marketing communication for the "Lendermarket Cup" (the "Campaign"). Lendermarket offers Users the opportunity to receive a promotional bonus ("Bonus") by investing newly deposited funds. By opting into and participating in this Campaign, Users agree to be bound by these Terms and Conditions ("Terms") and the Rules of the Platform ("Rules"). The terms used herein shall have the same meaning as described in the [Rules of the Platform](#) unless the context otherwise requires or is indicated differently in these Terms. This bonus is a promotional incentive and does not constitute an investment return or yield.

2. Periods of the Campaign

- 2.1. **('Opt-In Period')** from 11 June 2026 at 00:01 GMT+1 to 26 July 2026 at 23:59 GMT+1 (both inclusive).
- 2.2. **('Campaign Period')** from 11 June 2026 at 00:01 GMT+1 to 11 September 2026 at 23:59 GMT+1 (both inclusive).
- 2.3. **('Depositing Period')** from 11 June 2026 at 00:01 GMT+1 to 26 July 2026 at 23:59 GMT+1 (both inclusive)
- 2.4. **('Investing Period')** from 11 June 2026 at 00:01 GMT+1 to 26 July 2026 at 23:59 GMT+1 (both inclusive).
- 2.5. **('No Withdrawal Period')** from 11 June 2026 at 00:01 GMT+1 to 11 September 2026 at 23:59 GMT+1 (both inclusive).
- 2.6. **('Bonus Pay Day')** The bonus will be credited by 16 September 2026 at 23:59 GMT+1

3. Eligibility criteria

- 3.1. The User is entitled to the Campaign Bonus if all the following conditions are satisfied:
 - 3.1.1. The user has an active and verified Lendermarket account.
 - 3.1.2. The user has opted into the Campaign during the Opt-In Period.
 - 3.1.3. The User deposits New Funds via card or bank transfer during the Depositing Period. Multiple deposits may be made, provided the total of New Funds equals or exceeds €250.
 - 3.1.4. The User invests those newly deposited funds into any of the Listed Loans available on the Platform during the Investing Period.
 - 3.1.5. The User has not withdrawn any funds from their investor account during the No Withdrawal Period.
 - 3.1.6. From 14 July 2026 at 00:01 GMT+1 to 26 July 2026 at 23:59 GMT+1 (both inclusive), the geographic restrictions of this campaign relating to participants being tax residents of Germany, France, and/or Spain is waived, and Users of all tax residencies are eligible to participate in the Campaign.

3.2. Regulatory Verifications: In accordance with Anti-Money Laundering (AML) and "Know Your Customer" (KYC) requirements, users may be requested to provide additional documentation to verify the source of funds for their deposits. Eligibility for the Campaign and receipt of the Bonus are contingent upon the successful completion of these mandatory checks.

3.3. By entering this Campaign, the User agrees to accept and to be legally bound by these Terms and Conditions.

4. Calculation of campaign bonus

4.1. The Campaign bonus is calculated automatically for each User who meets the eligibility criteria outlined in Section 3.

4.2. The Campaign bonus is calculated based on new investments during the investing period using newly deposited funds according to the following table:

New deposits and investments amount	Bonus
€250 – €699	0.5% cashback bonus
€700 – €4,999	1.0% cashback bonus
€5,000 – €14,999	1.5% cashback bonus
€15,000 or more	2% cashback bonus

4.3. Maximum Cap Constraint: The maximum eligible investment amount per User for the calculation of the cashback bonus is capped at €50,000. Any newly deposited and invested funds exceeding €50,000 will not be eligible for additional cashback, limiting the maximum individual bonus payout under this Campaign to €1,000.

4.4. For example, a User who opted into the Campaign and subsequently made a new deposit of €10,000, which was used to acquire a Listed Loan on 21 June 2026, would be eligible for a Campaign bonus of €150 (1.5% of €10,000), provided they have not withdrawn any funds during the no-withdrawal period.

4.5. The User will receive the Campaign bonus only if all conditions set in these Terms have been fulfilled. *If the User withdraws any funds from their investor account, deposited before or during the No Withdrawal Period, the bonus will not be granted as it will not comply with clause 3.1.5.*

4.6. Each User may receive only one bonus payment under this Campaign.

5. Taxation

5.1. The eligible User shall be fully responsible for the calculation and payment of all taxes arising from the Campaign bonus obtained as a result of their participation in the Campaign. All bonuses will be paid without any deduction or withholding for or on account of any tax unless required by law. The User should seek independent tax advice where needed.

6. Termination and updates to Terms and Conditions

6.1. Lendermarket reserves the right to suspend or terminate the Investor's Accounts or deny any Campaign bonus if it notices any activity that Lendermarket reasonably believes is abusive, fraudulent, of a criminal nature, or does not comply with these Terms or any other agreements applicable to Users. This includes, without limitation, the misuse or abuse of Promo Codes.

6.2. Lendermarket may suspend or terminate the Campaign or a User's ability to participate in it at any time for any reason.

6.3. Lendermarket may, in our sole and absolute discretion, amend these Terms or terminate the Campaign unilaterally.

6.4. If Lendermarket, at its sole discretion, believes that the eligible User has created an account for the primary purpose of collecting the Campaign bonus and not using the services of Lendermarket, the User will be disqualified from this Campaign and will not be eligible for its rewards.

6.5. Lendermarket may review the payment information of the eligible User if it suspects a breach of these Terms.

7. Miscellaneous

7.1. Any dispute or claim arising out of these Terms, or its subject matter or formation (including non-contractual disputes or claims) shall be governed by these Terms and by the [Rules of the Platform](#) that have been published on the Platform at the moment when participating in this Campaign.

7.2. Campaign Auto Invest portfolio activation alone does not guarantee that all newly deposited funds will be invested, as loan availability may vary in accordance with normal market conditions on the Platform.

7.3. These Terms do not alter or in any way limit the use or terms of referral Campaigns, affiliate bonus programmes, promo codes or any other Campaigns with the exception of the GetQuin offer..
